Cruise Credit Feature

If your total Cruise cost and cancellation penalties exceed \$50,000 per Insured and you have a covered Trip Cancellation, you will be reimbursed \$50,000 in cash plus a future Regent Seven Seas cruise credit equal to the amount by which the cancellation penalties imposed exceed the \$50,000 per insured cash reimbursement. For covered Trip Interruption claims, the Future Cruise Credit will equal the amount by which the pro-rated amount of the Cruise cost remaining exceeds the \$50,000 per insured cash reimbursement covered by the plan. The Future Cruise Credit is non-transferable. Other restrictions may apply.
