- All persons entering the UK are required to perform a selfadministered PCR test no later than 2 days after arrival in to the UK (day of arrival is day zero).
- The mandatory Passenger Locator Form (PLF) which is completed by each individual prior to entry in to the UK requires proof of the purchase of a Day 2 test before arrival in the UK.
- Purchasing a Day 2 test generates a "test package booking reference #" which is entered in section 2 of the UK PLF.

## Testing after you arrive in the UK

You must book a coronavirus (COVID-19) test package for when you arrive in the UK.

- If you have only been in green list countries, you must book a day 2 test.
- If you have been in or travelled through an amber list country or island you must book tests for day 2 and day 8, **unless** you meet the <u>vaccine eligibility criteria</u>.


